DESCRIPTION

LOCATION

Gatwick Airport is approximately 3 miles way with Crawley Town Centre and Railway Centre 2 miles away as well as Three Bridges Station providing mainline services to London and Brighton. The M23 (Junction 10) is approximately 3 miles to the West which provides access to the M25 (Junction 7). Surrounding retailers include M&S Foodhall, Costa Coffee and Aldi at Acorn Retail Park and Snap Fitness and Tesco Express close by.


