The property is a former infant's school that most recently traded as a Prezzo Restaurant. It is a Grade II listed building, briefly comprising ground floor restaurant, kitchen, storage and W/C facilities; first floor mezzanine; first floor ancillary accommodation and outside terrace area.

The property is likely to appeal to a variety of uses that want to take advantage of the prominent nature of the building and local trade from nearby residents. The property is a Class E planning use suitable for a variety of uses (STNC).

The property is situated in a highly prominent position at the top of the High Street, at the junction of North Street and The High Street. The area receives a good amount of footfall from local residence and students who attend the nearby school as well as visitors to the area.

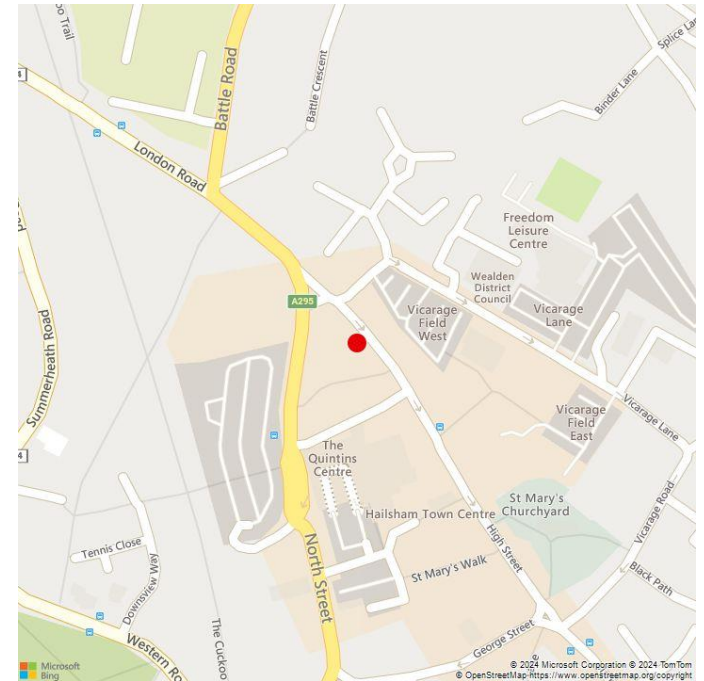
