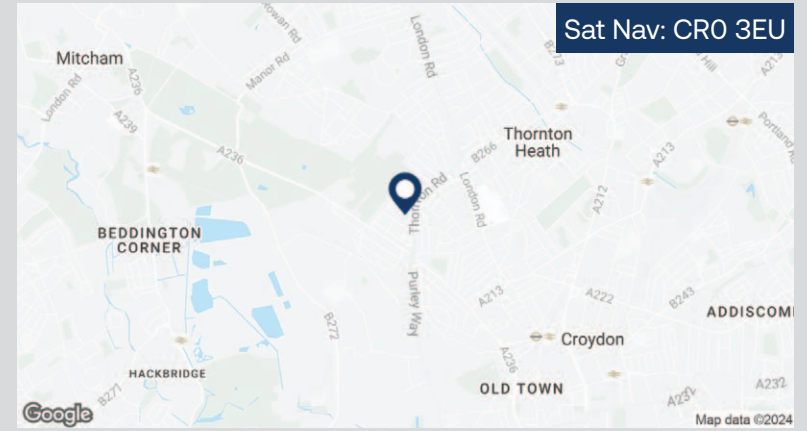

Description

The units are of steel portal frame construction with brick elevation and steel profile cladding. Nearby occupiers include Howdens Joinery, Carpets 4 All and Topps Tiles. The units benefit from a roller shutter door and loading area with first floor offices and yard / car parking to the front. Well suited to industrial, storage or trade counter occupiers.

Location

The units are located on Thornton Road Trade Centre, just off Thornton Road (A23) in Croydon. The estate is located immediately north of the Purley Way, approximately 10 minutes from Ampere Way Tram Station, giving access to London Overground services at East Croydon Station (10 minutes), Mitcham Junction (8 minutes) and Wimbledon (20 minutes).

The A23 links Central London (8 miles) with the M25 at Junction 7 (10 miles), providing access to the national motorway network.
